DATA PROTECTION ACT

- (c) that my application is actuated by the desire to participate in the Philanthropic and Social Objects of the Order, and that should I be accepted to membership, I do not expect to receive any pecuniary benefits therefrom
- (d) that I have never been convicted of any criminal offence (other than a minor traffic offence) (see note below)
