3. No member of Grand Lodge can be nominated for more than one office or position in Grand Lodge, except the Grand Primo, Immediate Past Grand Primo, Deputy Grand Primo and Grand Secretary – Rule 4:5.c.
4. The Official nominations must be in the hands of the Grand Secretary **by JUNE 30<sup>TH</sup>** in accordance with Rule 3:3.a.16.
5. The Grand Secretary will acknowledge all nominations received. In the absence of an acknowledgement within seven days of submission, please contact the Grand Secretary immediately.
6. Names cannot be placed on the ballot paper unless received by **JUNE 30<sup>TH</sup>**. Or absence of acknowledgement notified to the Grand Secretary in accordance with note 5.
